On April 16, 2022, the voting membership of the Rocky Mountain Paralegal Association was tasked to review and vote on candidates for the 2022-2023 Board of Directors. The following six (6) Candidates affirmatively accepted their respective nomination by the stated deadline and provided a statement of interest, all of which can be found on the <u>website</u>.

- a. President & Chief Executive Officer, Stefanie Trujillo (Incumbent)
- b. Chair: At-Large Director, D. Michelle Cole, CP (Incumbent)
- c. Director of Marketing & Development, Hannah Hughes
- d. Director of Administration, Zoe Albrecht
- e. Director of Academic Relations and Education (At-Large Director), Celeste Carpenter (Incumbent)
- f. Director of Association Activities (At-Large Director), Cachet Winterroth, CP (Incumbent)

On April 16, 2022, the Election Committee of the Rocky Mountain Paralegal Association called upon the voting members of the Association to submit their votes to appoint candidates as members of the Board of Directors for the stated term lengths.

At the commencement of the election, there were 122 active, in good standing, eligible voting members of the Association. Pursuant to Article 2, section 8 of the Association Bylaws, 25% of those voting members constitutes a quorum, or 31 votes. Voting members were offered an opportunity to vote for each candidate *or* to abstain from voting for the candidate. <u>Each position must have received a minimum of thirty-one (31) responding votes</u>. Failure to obtain sufficient number of votes would require a special election.

At the commencement of the election, an announcement was sent to all eligible voting members to solicit votes for the process that was posted on the Association Website. Additional messages were sent to eligible voters between the opening date and the closing date.

As of the closing of the election, **thirty-three (33)** votes were submitted for the election and therefore, it is the duty of this Committee to proclaim the election as VALID and all candidates are officially on the board as of May 1, and will be sworn in during the next regular monthly meeting on May 11, 2022 at 5:30 p.m. (Mountain).

To receive an appointment for any remaining vacant position, the nominee must receive a minimum of 50% + 1 of the 2022-2023 seated board. Currently, nine (9) members are seated on the board. A total of six (6) votes in the acceptance column must be received to be confirmed.
